Pumpkinvine brings increased business to local bike shop

With the coming of the Pumpkinvine Nature Trail, more bicycle shops are springing up throughout the Elkhart and LaGrange counties, while established shops are seeing more business. One of the latter is the County Line Bicycle Shop located at 5305 S on CR 1200 W, just north of Millersburg.

"The Trail has had a great impact on sales," owner John Mullet said. "Before the trail was built, people were satisfied to ride to the neighbors or even to the store with their old junkers, but now that they have a trail of 10 or 20 miles to cycle, they want bicycles that are, not only newer and in good repair, but also nice looking." The result is that "local bicycle users bring in their older bicycles—oft in need of repair—as trade-ins on brand new units that will take them the distance in either direction — for shopping and especially for pleasure riding on the Pumpkinvine."

On 'Sales Days' in April, Mullet often brings in the entire family and even in-laws to help with customers who come in for both new recumbents, tricycles, step-throughs and standard models or newly repaired, more economical units. And when women come in for a bike upgrade, Mullet has a variety of models and colors to meet their preferences, too. Mullet's primary brands are the Bacchetta Recumbent, Fuji and Jamis, but with the many trade-ins, other brands become available as well.

As a result of the increase in bicycles being traded in, Mullet has developed a rather unique method of recycling them—one that benefits his customers and the wider community: he donates them to good causes. "We have donated as many as 30 bicycles to other shops and fundraising causes in the interest of our primary purpose – to serve our customer base while helping other agencies to serve theirs," Mullet said.

His donations help his customers by allowing him to give more floor space to the new bikes they're looking for. "Since most trade-ins require service and take up more floor space than is profitable, we need to move them out as soon as possible," Mullet said. "I try to make bicycles both clean



and road worthy – with good brakes, good wheels, and good seats. And if I take in a good lady's bicycle and bring it up with those features, it will not be here long."

"We've had some not-for-profit bicycle shops like Chain Reaction in Goshen come looking for older bicycles, and we were ready to donate some of our stock in order to make room in our shop for the new ones we bring in. We also donate bicycles for fundraisers and auctions for friends and neighbors. It is good for business, and it helps the community, too," Mullet added.

In a strange twist of fortune, increased business has cut into his riding time. "Now that we have the Pumpkinvine, more cyclists want better bicycles to ride these trails," he said. "But as a result, my wife and I have less time to ride the trail ourselves. And there are so many more customers who want service on their schedules and often come after our closing hours. But there are times when we just have to close shop a little earlier so we can get some riding in, too."

Mullet and his wife Dorothy purchased the bicycle business from a previous employer some nine years ago. He sells between 250-300 units annually. He finds customers often want a bargain, "but," he said, smiling conscientiously, "as long as I continue to provide good service and good prices, they will come back to do business here." Of that there is no doubt.



From the president

You save money and the Friends of the Pumpkinvine receive \$25

The Friends of the Pumpkinvine Nature Trail, Inc. are always looking for new ways to help fund trail maintenance and expansion. We seek grants, donations from loyal supporters and corporate sponsors and also sale trail-related items like t-shirts, caps and jerseys. The June bike ride is another source of income.

Through this newsletter, our website and Facebook, we're promoting a unique fundraising opportunity that not only helps generate funds for the trail, but also pays dividends for our supporters.

This opportunity comes from Energizing Indiana, a cooperative venture of the



Indiana energy companies designed to help homeowners save on their utility bills and at the same time generate contributions to a nonprofit organization, like the Friends of the Pumpkinvine.

Energizing Indiana will donate \$25 to Friends of the Pumpkinvine for each household that completes a free home-energy assessment and designates the Friends of the Pumpkinvine as their beneficiary. The assessment can lower your home's energy consumption, improve your home's air quality and increase your home's value.

The best way to schedule an energy assessment with Energize Indiana is through a link to the Energizing Indiana website on our website homepage: http://www.pumpkinvine.org/. This link will take you to the Friends-of-the-Pumpkinvine scheduling page. It gives you the opportunity to schedule the assessment at your convenience and select the best appointment time. Here are the steps in the process.

- 1. Schedule your energy assessment through the link at www.pumpkinvine.org.
- 2. After you schedule the energy assessment, Energizing Indiana will contact you by phone to set up a time to make the assessment.
- 3. Then a representative of Energizing Indiana will come to your home and make the assessment. It takes about an hour. On that visit, they will inspect your home's exterior, attic, furnace and water heater and appliances for ways to reduce your energy bills. They will also bring an energy savings kit that includes 20 compact florescent light bulbs, energy-efficient faucet and showerheads and insulation for water-heater pipes—all installed for free.
- 4. Finally, the Energizing Indiana representative will give you an energy-assessment report outlining weatherization steps that could improve your homes energy efficiency. You may or may not follow up on their suggestions at your own expense.

In short, the assessment and the energy saving kit are free, further weatherization is up to you, and for every assessment made through our website, Energizing Indiana will donate \$25 to the Friends of the Pumpkinvine.

There are a few limitations to the program: your home must have been built before Jan. 1, 2010 and have had no utility sponsored energy assessment in the past three years.

I hope that you will take advantage of this opportunity to save on your energy bills and at the same time support the Friends of the Pumpkinvine Nature Trail, Inc.

Spring wildflower walk is April 27

Wildflower enthusiasts John and Joann Smith have identified over 30 spring wildflowers along the trail, including Spring Beauty, Trillium, Puttyroot, Bishop's Cap, Bellwort, Yellow Violet, Jack in the Pulpit and Common Blue Violet

However, since wildflowers tend to be much smaller than domesticated flowers, they are not always easy to spot. A guide can be very helpful.

For the past several years, the Smiths have been those guides, leading a spring wildflower walks on the Pumpkinvine and helping others discover and identify the flowers, giving some background on their distribution and how they are related to other plants.

This year the walk will be on April 27, starting at 3 p.m. and last approximately one hour. Because of limited parking at the wildflower area west of County Road 33, participants are encouraged to bike to the area. Bikers should meet at Abshire Park at 2:15 p.m.



Study of area trails shows economic impact

Readers of this newsletter instinctively know the Pumpkinvine is valuable for recreation and transportation, but is it possible to quantify its economic value and the value of other area trails? And while we love the Pumpkinvine Nature Trail, is

it more valuable by being connected to other trails where you can access yet more communities?

These are some of the questions we wanted to answer when we did surveys of area trail users between July 30 and Oct. 28, 2013. In addition to eight electronic counters placed along the Pumpkinvine Nature Trail, the MapleHeart, Millrace and Winona trails that counted trail users, volunteers stationed along the trails also administered over 300 surveys to trail users to find out why they were using the trail.

When we asked trail users what they were doing that day, many said recreation, but when we asked where they were going and what they were going to do when they got there, we discovered other activities as well.

Biking was the most common activity, but only 42 percent of users were just biking for the sake of biking. Eleven percent of trail users were also shopping or going to get food while using the trail. That number helps us understand the trails economic impact. In fact, spreading the estimated spending across all trail users, it averaged \$17.29 spent per trip. We further asked about spending for the purpose of using the trail, for example, on

bicycles or accessories. In the previous year, the average trail user had spent \$259.24 for the purpose of using the trail, another dimension of economic activity the trail helps to generate.

Three percent of the trail users described their trail use as commuting to work or school, an activity that has an economic impact for the individual who would spend less on gas, for example.



There were other benefits for our trails beyond money. Some recreation uses are simply round trips while others use the trails to travel to other communities. Another example was that 7 percent of those surveyed noted they used the trail for socializing with friends.

This data is but some of the early feedback from the study. A deeper analysis of the data is ongoing. For now you can be confident that the Pumpkinvine and other regional trails are worth building and using. It is an asset worth expanding.

We are grateful to Goshen College Professor of Economics, Jerrell Ross Richer, who had students from one of his classes analyze the survey data as a class project.

Items from the past newsletters and Pumpkinvine's history

Five years ago-Spring 2009

- National Trails Day, June 6, 2009, was announced as the date for the grand opening of 3.4 miles of the Pumpkinvine Nature Trail between CR 127 and CR 33 between Middlebury and Goshen.
- Grants to building the Pumpkinvine Nature Trail totaled \$3.4 million, the vast majority of which went to local companies.

10 years ago-Spring 2004

- The Friends' board appointed Jim Smith executive director and Bob Carrico trail operations manager.
- Town of Middlebury gave the Friends a plaque that read: "In appreciation to the Friends of the Pumpkinvine [Nature] Trail for outstanding contributions to the Town of Middlebury and Middlebury Park Board–Linear Greenway Park, 2004."

15 years ago-Spring 1999

- Jan. 14, 1999, the Friends donated 1.75 miles of the Pumpkinvine corridor between SR 4 and CR 28 to the city of Goshen.
- Bob Hatch and Mike Varner joined the Friends board.
- Friends of Pumpkinvine were debt free for the first time since 1993.
- Doug Mulvaney joins Jim Byron and Jim Brotherson on the Friends' legal team.
- A plaque inscribed with the names of the 91 trail Founders who gave \$500 or more to purchase the Pumpkinvine corridor will be placed at the trailhead in Abshire Park.

20 years ago-Spring 1994

- On Jan. 13, 1994, lawyers for the Friends, Jim Brotherson and Jim Byron, filed a quiet-title lawsuit in Elkhart County Superior Court No. 3 asking the court to resolve conflicting claims of land ownership between State Road 4 and County Road 28. Both lawyers are working pro bono because they believe the project is for the good of the community.
- March 18, 1994, the Friends sponsor a trail walk from



Friends of the Pumpkinvine transfer land to the city of Goshen: C.J. Yoder, Friends treasurer; Larry Beachy, Goshen park board; Allan Kauffman, Goshen mayor; Rich Fay, Goshen Park and Recreation director; John Yoder, Friends president; Everett Thomas, Goshen City Council; Merritt Lehman, Friends secretary, Jan. 13, 1994.

Abshire Park to CR 28 to show off the newly purchased Pumpkinvine corridor. Early in the walk, they encountered trail opponents blocking the trail with a barrier across the corridor constructed of a wire fence attached to railroad ties driven into the ground. The Friends used wire cutters to open a hole in the fence and proceeded to walk the trail from State Road 4 to County Road 28.


